WTF IS THE RADICAL INDOCTRINATION EO?

SUPPORTING AND AFFIRMING QUEER AND TRANS STUDENTS AND THE TEACHERS WHO TEACH THEM

What is an executive order (EO)?

Basically, they are signed statements about how the president wants the federal government to be managed. They can be instructions to federal agencies or requests for reports.

They are not law.

Congress could block an order from being fulfilled by removing funding or creating other hurdles.

Many of Trump's measures are likely to draw Democratic opposition.

In several major cases, the orders will largely be statements of intent based off campaign promises made by Trump.

There are limits to the power of executive orders:

Both Congress and the courts can potentially block executive orders.

There are also legal challenges based on the argument that a president exceeded his legal authorities.

What to know about "ending radical indoctrination in k12 schools" EO

In the purpose section, Donald Trump frames being trans as an "anti-American Ideology" designed to "sow distrust" and "undermine family unity."

It also fronts the **fringe claim** that title IX *MANDATES* discrimination against transgender students.

Definitions: Section e is the only applying to trans youth, but its a doozy...

It says that stopping "Social Transition" is going to be a big part of the EO, and this includes using a different name, pronouns, bathrooms, and sports.

This hints that the purpose of the EO will be to target this.

Sec 3(a) says that it is Trump's policy to eliminate federal funding for any school that supports "gender ideology."

Given the definitions section around social transition and other sections, this will likely mean schools that let trans kids use the bathroom, use their names, etc.

While the Order directs federal agencies to evaluate and report back on how to limit federal funding as described above, the Executive Branch has limited authority to put conditions on federal funds.

Article I, Section 8 of the United States Constitution gives Congress (not the Executive Branch or federal agencies such as the Department of Education) authority over the terms of federal spending in most instances.

The executive branch can't pull funding unilaterally. Under nondiscrimination laws including Title IX and Title VI, the department's office for civil rights would have to investigate allegations, find a violation, and also find that the school is refusing to address the violation.

The department would recommend a funding termination, and there would be a waiting period, during which Congress could override the department's attempt to terminate funds.

School districts can also appeal funding termination decisions.

Sec 3(c): chilling. It directs the Attorney General and state Attorneys General to go after teachers that allow social transition for "sexually exploiting minors" or "practicing medicine without a license."

This is likely going to be used to terrorize school districts and teachers with trans kids, and the kids themselves.

While this and other Executive Orders have caused much uncertainty, threats of prosecution against educators for "unlawfully facilitating the social transition of a minor student" appear to lack legal foundation in current federal law.

This is perhaps his most blatantly illegal EO of the anti-trans ones.

Keep teaching.

The Education Department, its secretary, and the federal government have no authority over curriculum matters.

Within the last decade, Congress tightened up this very language to make clear that the states are fully in control of curriculum and academic standards.

TLDR:

It will depend on teachers and school systems complying in advance...

Don't do it. Do not comply.

Actions: call/write your representatives
